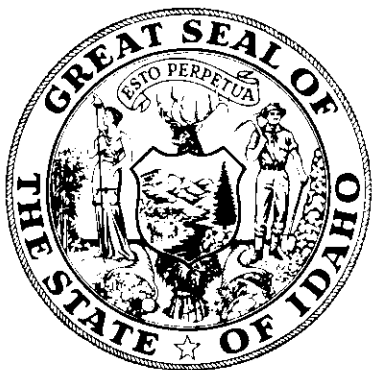

ARTICLES OF INCORPORATION
OF
ALPHA OMEGA, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is ALPHA OMEGA, INC.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are these: creation, publication, dissemination and instruction of educational materials and any other lawful purposes.

IV.

The aggregate number of shares which the corporation shall have authority to issue is TEN THOUSAND (10,000). No par value.

V.

The address of the initial registered office of the corporation is 1530 Stiner Avenue, Coeur d'Alene, Idaho, 83814, and the name of its initial registered agent at such address is Charles R. Whitlock.

VI.

The number of directors constituting the initial board of directors of the corporation is two, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are the following:

VII.

The name and address of each incorporator is:

VIII.

The number of shareholders shall be limited to FIFTEEN (15), all of whom must be persons: no corporation shall be a shareholder of this corporation.

There shall be only one class of shares, a restriction required by the Internal Revenue Code of the United States.

IX.

Transfer of shares shall be restricted because this corporation is electing to have the status of a Small Business Corporation under Subchapter S of the United States Internal Revenue Code (26 U.S.C.A. Section 1371 et seq.)

The shareholder must offer shares to the corporation or to any other holders of shares of the corporation or to any other person or to any combination of the foregoing, a prior opportunity, to be exercised within a reasonable time, to acquire the restricted shares.

X.

Provisions for the regulation of the internal affairs of the corporation are contained in the by-laws of this Corporation.
