ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is CLEMONS, COSHO & HUMPHREY, P.A.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the shareholders and directors of the corporation by written action and consent dated August 31, 1990, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, That Article I of the Articles of Incorporation of Clemons, Cosho & Humphrey, P.A., an Idaho corporation, be amended to read as follows:

"The name of the corporation is COSHO, HUMPHREY, GREENER & WELSH, P.A."


