KNOW ALL MEN BY THESE PRESENTS: That we, TIMBERLINE BEEF, INC., an Idaho Corporation, GRANT DANIELS, BOYD BURNETT, RODNEY S. PEARSON, M. TODD PERKES, JOHN McAFFEE, and SOELBERG FARMS, INC., have associated ourselves together with the purpose of forming a body corporate, in accordance with the provisions of the non-profit corporation Laws of the State of Idaho, and do hereby make, execute and acknowledge these Articles in writing.

### ARTICLE I.

The name of the Corporation is TIMBERDOME CANAL CO., INC.

## ARTICLE II.

The period of its duration shall be perpetual.

#### ARTICLE III.

The objectives and purposes for which said Corporation is formed are:

- (a) To construct, maintain, purchase, lease and operate an agricultural irrigation system for its members, including any related facilities as may be necessary, all of which activities of the Corporation shall be for the benefit of its shareholders, and not for the purpose of gain to the Corporation.
- (b) To acquire or lease, maintain, and operate machinery and equipment for the use and benefit of the members.
- (c) To hold, purchase, acquire, lease and convey real and personal property; to borrow money for the use and needs of the Corporation; and to pledge and/or mortgage real, personal, and intangible property of said Corporation, as security for indebtedness incurred.

- (d) To levy assessments upon its members for: the acquisition by lease, purchase, or otherwise, of lands; the construction, operation, maintenance of equipment and facilities and improvements thereto; the payment of the lawful obligations of the Corporation.
- (e) To sue and to be sued, complain and defend in any court of law or equity.
- (f) To have a Corporate Seal which may be altered at pleasure, and to use the same by causing it or a facsimile of it, to be impressed or affixed or reproduced or otherwise.
- (g) To elect such officers and appoint such agents as the business of the Corporation shall require and to allow such appointed agents suitable compensation.
- (h) To make Bylaws not inconsistent with the Constitution or laws of the United States, or of this State, for the management of its property; the operation of its business; and the regulation and government of its affairs; and for the execution and transfer of its membership certificates.
- (i) To do any and all things that may be incident to or conducive of the aforesaid objectives, or any of them, and exercise the usual powers of corporate bodies consistent with the laws of this state, except as herein prohibited or forbidden or restricted by the Bylaws of this Corporation.

### ARTICLE IV.

The affairs of the Corporation are to be managed by the Board of Directors which consist of 7 members. The Directors shall be elected at the annual meeting of the shareholders and shall hold office until their successors are elected in accordance with the provisions of the Bylaws. The Incorporators, or the designees of Incorporators, shall serve as Directors until the first annual meeting of the shareholders, or until their successors are duly elected, and they are:

	ARTICLE V.	

The Board of Directors of the Corporation shall elect a President, Vice-President, Secretary and a Treasurer, which latter two offices may be combined. Each Officer shall serve a term of one (1) year, or until his successor is elected and qualified pursuant to the By-laws.

### ARTICLE VI.

SECTION 1: The authorized Capital Stock of this Corporation shall be \$50,000.00, divided into 5,000 shares of a par value of \$10.00 each.

SECTION 2: Ownership of the shares shall be limited to corporations, partnerships and natural persons who own or have a possessary right to farm lands which may be conveniently and economically served by the water production and delivery system of the Corporation.

SECTION 3: Share ownership shall represent the right to share, proportionately with other shareholders of the Corporation in the use and facilities of the Corporation, subject to the provisions of the By-laws and Regulations adopted by the Board of Directors, and from time to time duly amended and/or supplemented.

SECTION 4: Shares in this Corporation shall be transferrable and subject to mortgage or pledge only on approval of the Board of Directors. This restriction shall be recited on all Share Certificates issued.

# ARTICLE VII.

Further provisions for the management of the Corporation, the qualifications of membership, the conduct of its affairs, and the powers, duties and privileges of its directors, officers, committees and membership shall be as set forth in the By-laws and any amendments thereof.

## ARTICLE VIII.
