1 ARTICLES OF INCORPORATION

2 OF

3 SNAKE RIVER VENDING SERVICE, INC.

4 KNOW ALL MEN BY THESE PRESENTS:

5 That we, the undersigned, being natural citizens of
6 full age and citizens of the United States of America, in order to
7 form a corporation, for the purpose hereinafter stated, under and
8 pursuant to the provisions of the general laws of the State of
9 Idaho, do hereby certify as follows:

10 ARTICLE I

11 The name of the Corporation shall be "SNAKE RIVER VENDING
12 SERVICE, INC."

13 ARTICLE II

14 The Corporation's purposes are:

15 (A) To purchase, rent, lease, design, patent, manufacture,
16 produce, and otherwise acquire, own, hold, deal in, prepare for
17 market, sell, exchange, lease or assign, and otherwise dispose of,
18 operate, provide service for, and deal with either as principal or
19 agent and upon commission or otherwise any and all types of vending
20 machines or vending devices, whether operated manually, mechanically,
21 electrically, or otherwise, now in use or which may be hereafter
22 invented or created.

23 (B) To establish, install, and maintain automatic
24 vending machines designed to vend and distribute goods, wares and
25 merchandise and any other commodity, specialty, and notion and to
26 engage in such other activity as may be necessary to vend and
27 distribute the products through the machines.

28 (C) To act as a partner or in a joint venture in any
29 transaction.

30 (D) To purchase, improve, develop, lease, exchange,
31 sell, dispose of or otherwise deal in real estate and personal
32 property for the purpose of the corporation and to purchase, lease,

1 build, construct, erect; occupy and manage buildings of every kind
2 and character; to finance and purchase, improve and develope,
3 construct any land and buildings belonging to or acquired by the
4 corporation or any other person, firm or corporation;

5 (E) To have and exercise all rights, and powers from
6 time to time granted to the corporation by the statutes of the State
7 of Idaho or such other place or places and states as the corporation
8 may from time to time conduct its business.

9 ARTICLE III

10 The corporation is to have perpetual existence.

11 ARTICLE IV

12 The location of the principal office of the corporation
13 is 112 East 11th Street, Burley, County of Cassia, State of Idaho,
14 and the post office address of the corporation is 112 East 11th
15 Street, Burley, Idaho.

16 ARTICLE V

17 The total number of shares which the corporation is
18 authorized to issue is two hundred fifty (250) shares, all of
19 which shall be without par value. The Board of Directors, may
20 from time to time, fix the consideration for which said shares,
21 without par value, shall be issued and sold and when said shares
22 are issued and sold, they shall be fully paid and non-assessable.

23 ARTICLE VI

24 At all meetings of the stockholders every stockholder of
25 record shall be entitled to one (1) vote for every share of stock
26 standing in his or her name on the books of the corporation. In
27 the election of directors, every shareholder of record, calculating
28 the number of votes to which he or she may be entitled, shall have
29 the right to multiply the number of his or her shares by the
30 number of directors to be elected, and he or she may cast all of
31 such votes for any one candidate or may distribute them among two
32 or more candidates.

ARTICLE VIII

The Board of Directors shall consist of not less than three (3) nor more than five (5) directors. During the term of office, or thereafter, the number of directors may be increased or decreased from time to time as provided by the by-laws; PROVIDED, HOWEVER, that the number of directors constituting the Board shall never be less than three (3) nor more than five (5).

ARTICLE IX

The power to make, repeal, amend the by-laws, adopt new by-laws is hereby conferred upon the directors as well as upon the shareholders.

ARTICLE X

No contract or other transaction between the corporation or any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the corporation, and no action of the corporation shall in any way be affected or invalidated by the fact that any of the directors of the corporation are pecuniarily or otherwise interested in or are directors or officers of such other corporation; any director individually may be a party to or may be pecuniarily or otherwise interested in any contract or transaction of this corporation, and any director of the corporation who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the corporation, which shall authorize such contract or transaction, and may vote thereon to authorize such transaction or contract with the same right, force and effect

1 as if he were such director or officer of this corporation for such
2 other corporation and not so interested therein.
