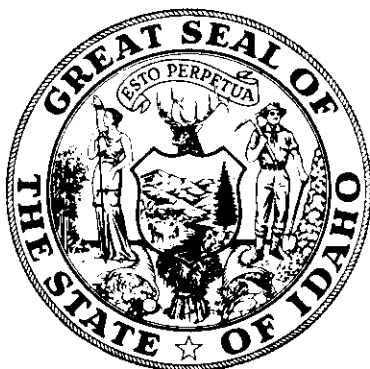

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes herein-after stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho, and the Acts amendatory thereof and supplemental thereto, do hereby certify as follows:

FIRST

The name of the corporation is The Solar System, Inc.

SECOND

The purpose and objects for which the corporation is formed are:

To purchase for resale or manufacture for sale and/or install and service any and all types of energy equipment and supplies and those items necessary or coincidental to such activities.

THIRD

The corporation is to have perpetual existence.

FOURTH

#### FIFTH

The amount of capital stock of this corporation shall be and is 5,000 shares of stock of the par value of \$1.00 each, making an aggregate stock of \$5,000, which stock shall not be issued until fully paid for and once so issued shall be nonassessable.

#### SEVENTH

The private property of the stockholders of the corporation shall not be subject to the payment of corporate debts to any extent whatever, and the shares of the corporation shall not be subject to assessment for the purpose of paying expenses, conducting business, or paying debts of the corporation.

#### EIGHTH

The number of directors of the corporation shall be as specified in the By-Laws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws, and in accordance with Section 30-139, Idaho Code. In case of any increase in the number of directors, the additional directors may be elected by the directors then in office, and the directors so elected shall hold office until the next annual meeting of the stockholders and until their successors are elected and qualified.
