ARTICLES OF INCORPORATION OF THE FULL GOSPEL PENTECOSTAL ASSEMBLY, OF IDAHO.

## KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned Trustee of the Full Gospel Pentecostal Assembly church, of the City of Rupert, Minidoka County, State of Idaho, duly appointed according to the regulations of said Church and in whom is vested the legal title to certain property of said Church, do hereby subscribe to and make the following articles of Incorporation.

## AND I HEREBY CERTIFY:

First: That the name of said Corporation, by which it shall be known, is "The Full Gospel Pentecostal Assembly, of Idaho." Second: That the place where its principal business is to be transacted is at the City of Rupert, Minidoka County, Idaho.

Three: That the object of this Corporation shall be purely religious and pecuniary profit is not and shall not be the object thereof.

Fourth: That the estimated value of the property belonging to said corporation at the time of making these irticles of Incorporation is Six Thousand Dollars (\$6,000.00), lawful money of the United States of America.

Fifth: That the title of the person making these irticles of Incorporation is "Trustee of the Full Gospel Pentecostal Assembly" of the City of Rupert, Minidoka County, Idako.
