ARTICLES OF INCORPORATION

OF

BOUNDARY VOLUNTEER AMBULANCE SERVICE, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS: That we whose names are hereto affixed, all of whom are bona fide residents and full-age citizens of the United States of America, do under and in pursuance of Idaho Code 30-1001 et seq. of the Idaho Code as amended, and general corporation laws of said State, hereby organize, constitute and associated with us, in accordance with these Articles, into a body politic, and corporate for the purposes hereinafter set forth, and to that end we execute these Articles of Incorporation, and hereby certify, set forth and declare as follows:

I.

NAME

The name of this corporation is BOUNDARY VOLUNTEER AMBULANCE SERVICE, INCORPORATED.

II.

PURPOSES

The purposes of this organization shall be:

To render aid and assistance to victims of illness and accident.

To transport the ill and injured to and from places where medical assistance is rendered.

To assist in matters of National Defense.

To render assistance in times of disaster as proclaimed by a city within Boundary County, Idaho, by Boundary County, Idaho, by the State of Idaho, or by the Nation.

To do all things and render all service normally associated with the conduct and operation of an ambulance service, except that at no time shall the total corporate indebtedness exceed \$15,000.00.

To acquire by gift, devise, grant and purchase real and personal property and to sell, encumber and otherwise dispose of the same for the benefit of this organization, and/or to use it for the purposes

thereof. Disposal of property shall be had only after a two-thirds vote of approval from members present at any regular meeting.

To be a benevolent corporation for the welfare of the general public.

To generally engage in, do and perform any enterprise, act or vocation that a natural person might or could do or perform so long as in conformance with the other purposes herein enumerated.

To engage in the business of buying, acquiring, giving, owning, leasing, transferring, encumbering and generally dealing in real and personal property so long as in conformance with the other purposes herein enumerated.

The purposes herein shall be construed both as purposes and powers and shall be in no wise limited or restricted by reference to, or inference from, the terms of any other clause in this or any other article, but the purposes and powers specified in each of the clauses herein shall be regarded as independent purposes and powers, and the enumeration of specific purposes and powers shall not be construed to limit or restrict in any manner the meaning of general terms or of the general powers of the corporation, nor shall the expression of one thing be deemed to exclude another, although it be of like nature unexpressed.

To do all and every thing necessary, suitable and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects and purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and also so long as in conformance with the other purposes herein enumerated.

BURATION

The duration of the corporation is perpetual.

IV.

LOCATION

The location is Boundary County, Idaho; and the post office address of the registered office of the corporation in the State of Idaho is Bonners Ferry, Idaho.

V.

MEMBER SHIP

Any person shall be eligible to membership who qualifies under requirements as set from time to time in the By-Laws. The rights and interests of all members shall be equal, and no member can have or acquire a greater interest therein than any other member.

VI.

DIRECTORS

The corporate powers of this corporation shall be vested in a board of five (5) Directors, to be elected as provided in by-laws of this corporation. To be a director a person must be a member. The powers and duties of the officers of this corporation shall be as prescribed in the By-Laws.
