ARTICLES OF INCORPORATION

OF

Bob's MART, Inc.

27 870 20 10 34

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Bob's MART, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any and all lawful business for which corporations may be incorporated within the State of Idaho. Said purposes shall include but not be limited, to investments in real estate and the buying, selling, and dealing in goods and articles for resale to the public.

FOURTH: Capital stock shall be ONE HUNDRED THOUSAND DOLLARS. The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares at a par value of one hundred dollars (\$100.00).

FIFTH: Provisions for the regulation of the internal affairs of the corporation are as governed by the By-Laws.

SIXTH: There shall be a restriction on the transfer of any interest whatsoever of the stock of this Corporation. Restriction on the transfer of interest shall be governed by provisions as set forth in the By-Laws.

SEVENTH: The address of the initial registered office of the corporation is 300 N. Seventh and Lander, Pocatello,

Idaho, 83205-4747, and the name of its initial registered agent at such address is Herman J. McDevitt.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is three (3), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
