

Re Use of "banc" in company name

Dear Mr. Cammarn:

This is in response to your correspondence of February 19, 1999, asking whether Banc of America Investment Services, Inc. may use the word "banc" in its name in Idaho. The company is a direct subsidiary of NationsBank, N.A., a national banking association, and is a wholly owned indirect subsidiary of BankAmerica Corporation. The company engages in securities brokerage and annuity sales, as well as other related activities.

Although we are taking no action to either approve or disapprove of the use of the name BancSource, you should be aware that if there is a regulatory implication.

Idaho Code §26-1202 makes it a felony for any person, other than a national bank; not authorized to operate as a bank under the Idaho Bank Act, to advertise or use as part of its corporate name the word "bank" or "banker" or any other word of similar import. While the Department of Finance does not have the authority to prosecute under this statute, another agency could conceivably do so. The Department is therefore not in a position to specifically approve such use.

It is our belief that the use of the term "banc" under the circumstances you have described is not misleading to the general public. We are therefore recommending to the Director that the Department take a "no action" position on your use of the word "banc".
