THE UNDERSIGNED Hereby incorporates itself as a nonprofit corporation,
under the Idaho Nonprofit Corporation Act of the State of Idaho [§§30-301ff.
I.C.].

ARTICLE I

The name of this corporation is:

WPG OF IDAHO PRODUCTIONS, INC.

ARTICLE II

The corporation is a nonprofit corporation.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

The corporation is organized to do any or all things, permitted by
law, in producing and developing films and other aids and resource materials,
for the education and training of persons born at Papua, New Guinea, and in the
development and operation of a school or schools, for the dissemination of such
materials and educating and training of such persons.

ARTICLE V

The corporation is to have no members, and the corporation which has

ARTICLE VI

a. The corporation is not organized for pecuniary profit, and
no part of its net earnings shall inure to the benefit of the incorporator, or
any director or other individual; and the balance of all money received by the
corporation for its operations, after the payment in full of all debts and obli-
gations of the corporation, shall be held, used, or distributed, exclusively


