Article 3. Statement is made that the notice required by section 30-1-87, Idaho Code, was given.

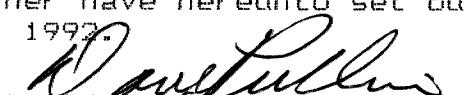
Article 4. Statement is made that all debts, obligations, and liabilities of the corporation have been paid and discharged.

Article 5. Statement is made that all the remaining property and assets of the corporation have been distributed among the shareholders in proportion to their respective rights and interests.

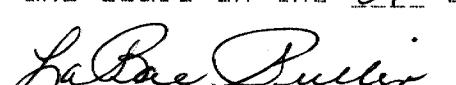
Article 6. Statement is made that there are no suits pending against the corporation in any court.
