**ARTICLES OF INCORPORATION  
OF  
IDAHO COCA-COLA JUNIOR RODEO ASSOCIATION, INC.**

Effective the 15<sup>th</sup> day of September, 1997, we, the undersigned natural persons of the age of twenty-one (21) years or more, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE 1: NAME**

The name of this Corporation is: Idaho Coca-Cola Junior Rodeo Association, Inc., and the address of the principal office is 7807 Floating Feather Rd., Eagle, Idaho, 83616.

**ARTICLE 2: DURATION AND MEMBERSHIP**

The corporation shall have no members and shall exist perpetually or until dissolved according to law.

**ARTICLE 3: PURPOSES**

This Corporation is organized for the basic purpose to do all things reasonable and proper in the operation of a junior rodeo association and to deal generally therein. This Corporation shall have all rights and powers normally ascribed to and incidental to said basic purpose and to business operations in general. This Corporation shall also have as its purpose the pursuit and development of any other business opportunities for which corporations may be organized under the laws of the State of Idaho. This Corporation may engage in any other lawful activities providing that its Bylaws and/or records reflect proper action permitting such activity.

**ARTICLE 4: PURPOSES AND POWERS**

The corporation is a nonprofit corporation under the laws of the State of Idaho. The corporation is not formed for pecuniary profit. No part of the income or assets of the corporation

is distributable to or for the benefit of its Incorporators, Directors or Officers, except to the extent permissible under law. The Corporation shall have all powers allowed by law.

#### **ARTICLE 5: NON-STOCK CORPORATION**

The corporation shall not issue certificates of stock and no dividends or pecuniary profits shall be declared or paid to the Incorporators and Directors thereof.

#### **ARTICLE 6: BYLAWS**

Provisions for the regulation of the internal affairs of the Corporation shall be set forth in the Bylaws.

#### **ARTICLE 7: REGISTERED OFFICE AND AGENT**

The address of the registered office of the corporation is 805 W. Idaho St, Ste. 403, Boise, Idaho, 83702 and the name of its initial registered agent is Rick D. Bailey.

#### **ARTICLE 8: DIRECTORS**

The number of directors which shall constitute the Board of Directors of the Corporation shall be fixed by the Bylaws, but in any event shall not be less than three (3). The number of directors constituting the initial Board of Directors of the Corporation shall be seven (7) and the names and addresses of the persons who are to serve as Directors until their successors are elected and shall qualify are:
