KNOW ALL MEN BY THESE PRESENTS:

That I, the undersigned, being a natural citizen of the United States and of full age and majority, have this day and do hereby voluntarily associate myself for the purpose of forming a corporation under the laws of the State of Idaho, and I do hereby certify:

ARTICLE I.

The name of this corporation shall be ROBERT B. POULSEN & COMPANY, P.A.

ARTICLE II.

The purposes and objects for which this corporation is formed are:

1. To generally engage in, do and perform all types of accounting, auditing and other services associated therewith as authorized pursuant to the provisions of the Idaho Business Corporation Act and the Professional Service Corporation Act.
