## FIRST

Any stock or obligations issued by the corporation shall first be offered to the stock holders of the corporation.

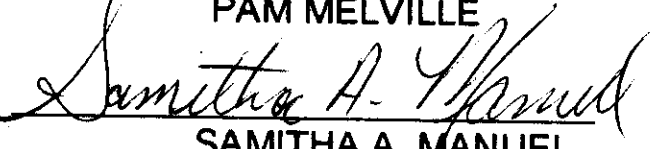
