Articles of Incorporation.

The Stanley Basin Dredging Company.

The undersigned, Citizens of the Territory of Oklahoma, do hereby voluntarily associate ourselves together for the purpose of forming a private corporation under the laws of the Territory of Oklahoma and do hereby certify:

First.

That the name of this corporation shall be the Stanley Basin Dredging Company.

Second.

That the purpose for which this corporation is formed are to buy, let, lease, and sell mineral lands, and to mine the same for any and all kinds of minerals, by and or all kinds of methods, and to construct water ditches and flumes, and to build wagon roads to mineral lands, and to do a general dredging and mining business, and all things appertaining and incidental thereto.

Third.

That the places where its principal business is to be transacted are the City of Perry in Noble County, Oklahoma Territory, and at such other places in any of the States and Territories of the United States, as may be selected and designated by the Board of Directors.

Fourth.

That the term for which this corporation is to exist is Twenty (20) years.

The number of directors or Trustees of this corporation, and names and residence of such of them who are re-serve until the election of such officers, and their qualifications,
