## ARTICLES OF INCORPORATION OF B & R FARMING CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

WE, THE UNDERSIGNED, C. V. CAMPBELL, ROSE CAMPBELL and JOHN CAMPBELL, each being at least twenty-one (21) years of age and residents of the State of Idaho, and all being citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, do, under and by virtue of the general laws of the State of Idaho authorizing the formation of corporations, associate ourselves as incorporators with the intention of forming a corporation and do hereby certify as follows:

I.

B & R FARMING CORPORATION.

II.

The purposes for which this corporation is formed are:

- (a) To lease, own and operate agricultural lands, buy and sell livestock and carry on a general ranching operation, including but not limited to the following:
  - To buy, receive, use, lease, mortgage, sell or otherwise deal with, in or on behalf of all types of personal and real property;
  - 2. To hold, own and to acquire for certificates of convenience of necessity, licenses and franchises from state, city, county or federal agencies as required in the furtherance of the corporation's business.
  - 3. To lease, buy, sell, use, mortgage, improve or otherwise own, operate, handle, deal in, or dispose of such property as vehicles, equipment, or any other property, real or personal, as may be necessary, convenient or useful in connection with the business of the corporation.
  - In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation and to enhance the form of its properties and to do all other things necessary for the protection or the benefit of the corporation.

TTI.

The corporation is to have perpetual existence.

The number of directors of the corporation shall be three (3), which shall be increased or decreased pursuant to the By-laws of the Corporation and shall never be less than three (3). The By-Laws of the Corporation shall provide for a time, manner and place of holding elections. The regulation of the internal affairs of the corporation shall be provided for by the By-Laws of the corporation.

VI.

The total authorized number of par value shares is 10,000 shares. It shall have \$1.00 par value per share. The 10,000 shares shall be identified as Voting Stock.
