ARTICLES OF INCORPORATION

L. K. D. CONSTRUCTION CO., INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America, and residents of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

I

That the name of said corporation is "L. K. D. Construction Co., Inc."

II

That the purposes for which said corporation is formed are: To carry on a business in the State of Idaho and in the United States of America and elsewhere as a general construction contracting firm, to build and construct buildings of any and all types, roads, bridges or any other type of work requiring construction, and to do all work necessary in preparation for such construction including the raising of existing structures and making excavations of all types and the construction of ditches, canals, or any other types of excavation and earthmoving work; and to do and perform all other acts which may be incidental to the proper carrying out of said business.

To own, rent, lease or maintain any building or buildings necessary for the housing and carrying on of the purposes of this business, or to own, rent or lease any personal property used in connection with such business.

To acquire, own, hold, sell, lease, pledge, mortgage or otherwise dispose of any property real or personal, necessary to the operation of the L. K. D. Construction Co., Inc.

To borrow money, contract debts, make contracts and to exercise any and all such powers as a natural person can lawfully make, do, perform or exercise, which may be necessary, convenient or expedient for the accomplishment of any of its objects or purposes provided the same shall not be inconsistent with the laws of the State of Idaho and to that end, innumeration of such powers shall not be deemed inconclusive. Such corporation shall have the power to own and acquire real and personal property of any and all description necessary to the convenient carrying on of its business.

### III

This corporation shall have perpetual existence.

### IV

The location and post office address of the registered office of the corporation is Inkom, Bannock County, Idaho.

### V

That the total authorized number of par value shares is 25,000 shares of common stock of the par value of \$1.00 per share. Each share of stock is equal to any other share and entitles the holder thereof to one vote for each share of stock which is held by him or her. The total aggregate par value of the authorized shares is \$25,000.00.
