ARTICLES OF INCORPORATION OF WELCOME TO THE FAMILY MINISTRIES, INC.

WE, THE UNDERSIGNED, being of legal age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE ONE. NAME, LOCATION, AND REGISTERED AGENT. The name of the corporation shall be "Welcome to the Family Ministries, Inc.," and its initial registered office shall be 813 Camas Street, Winchester, Idaho 83555. The name of the registered agent at such street address is The Reverend Stephen A. Bly. The mailing address for the corporation is Post Office Box 157, Winchester, Idaho 83555.

ARTICLE TWO. DURATION. The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE THREE. NONSTOCK CORPORATION. The corporation shall be nonstock and no dividends or pecuniary profits shall be declared. Membership shall be by certificate of membership.

ARTICLE FOUR. PURPOSES. The objects and purposes for which this corporation is formed are as follows:

- (a) to promote Christian education and evangelism;
- (b) to buy, sell, lease, let, mortgage, exchange, or otherwise acquire or dispose of lands, buildings, and any real property, hereditaments, and appurtenances of all kinds and wheresoever situate, necessary or desirable in connection with the business of the corporation, and to buy, sell, acquire, hold,

own, mortgage, pledge, lease, assign, transfer, and trade in all kinds of personal property, goods, wares, and merchandise of very kind, nature, and description in connection with the business, objects, and purposes of this corporation;

- (c) to accept and receive donations of moneys and other properties, real and personal, by gift, grant, devise, bequest, or otherwise, and to hold, own, manage, administer, lease, use, operate, sell, transfer, and convey such moneys and properties for the objects, uses and purposes of this corporation.
- (d) to make, perform, and carry out contracts of every kind and description made for any lawful purpose, without limits as to amount, with any persons, firms, associations, or corporations, either public or private, or with any government agencies thereof;
- (e) to borrow money, to draw, make, accept, endorse, guarantee, transfer, assign, execute, and issue notes and other evidences of indebtedness, and for the purpose of securing any of its obligations or contracts to convey, transfer, assign, deliver, mortgage, or pledge all or any part of the property of assets of any kind owned or held by this corporation, upon such terms and conditions as the Board of Directors shall authorize or as may be permitted by law;
- (f) to have one or more officers to carry on all or any part of its operations and business, and to do all and everything necessary, suitable, desirable, and proper for the accomplishment ARTICLES OF INCORPORATION

of any of its purposes, or the attainment of any one or more of the objects herein named, or which shall at any time appear conducive or expedient for the protection or benefit of the corporation or which now or hereafter may be authorized by law, and this is to the same extent and as fully as natural persons might or could do, either alone or in connection with any person, firm or corporation;

(g) to have and to exercise any and all powers and privileges now or hereafter conferred by the laws of the State of Idaho upon corporations formed under the corporation law of the State of Idaho or any act amendatory of supplemental thereto or substituted therefor, except such as are inconsistent with the provisions of Chapter 10 of Title 30 of the Idaho Code and any act amendatory or supplemental thereto.

The foregoing clauses are to be construed both as objects and powers and it is hereby expressly provided that enumeration herein of specific objects and powers shall not be held to limit or restrict in any manner the general powers of the corporation; provided, however, that nothing contained herein shall be deemed to authorize or permit the corporation to do any act, carry on any business, or exercise any power which a corporation formed under the nonprofit corporation provisions of the statutes of the State of Idaho, or any amendment thereof or supplemental thereto or substitute therefor, may not at the time lawfully carry on or do.
