ARTICLES OF INCORPORATION

OF THE

SEAMAN'S 2ND SUBDIVISION WATER USERS' ASSOCIATION, INC.

KNOW ALL MEN BY THESE PRESENTS That we, the undersigned citizens of full legal age of the United States, have this day voluntarily associated ourselves for the purpose of forming a non-profit cooperative association, pursuant to the laws of the State of Idaho (Idaho Code Section 30-1001) with the rights, powers, and privileges incident thereto and for such purpose enter into and adopt the following Articles of Incorporation.

ARTICLE I.

The name of the corporation is SEAMAN'S 2ND SUBDIVISION WATER USERS' ASSOCIATION, INC.

ARTICLE II.

The object and purposes for which the corporation is organized are as follows:

To encourage the conservation of water by members of the corporation; to furnish and supply water to members of the corporation by means of the cooperative efforts of the members of the corporation, and to promote the most efficient use of water by members. To cooperate in creating for the members for this corporation a stable, pure and continuing supply of water for the domestic, and other use and uses of the members thereof.

And for these purposes:

(a) To lease and own real and personal property and to enter into any and all contracts that may become necessary to the carrying out of the purposes aforesaid.

(b) To buy, sell, own, lease and improve real estate which may be required or deemed necessary or convenient for the purpose of carrying on any of the objects of the corporation.

(c) To buy, sell and deal in goods, wares, merchandise and all kinds of refreshments, equipment, apparatus and appliances.

(d) To own, lease, provide and furnish club rooms, rooms, meals, refreshments, games, devices and other conveniences in connection therewith.

(e) To contract debts and issue bills, notes, mortgages, bonds and debentures.

#### ARTICLE III.

The principal place of business of said corporation shall be at Boise, Ada County, Idaho.

#### ARTICLE IV.

The period of existence of this corporation shall be perpetual.

#### ARTICLE V.

The government and business affairs of this corporation shall be managed by a board of not less than five directors to be elected from the members as fixed by the by-laws of the association.

The directors to act until their successors are elected and qualified shall be:

#### ARTICLE VI.

The corporation is not organized for pecuniary profit and has no capital stock.

#### ARTICLE VII.

The membership of this corporation shall consist of the signatories to these articles and such persons as may from time to time be elected to membership in the corporation by the affirmative vote of a majority of the board and in compliance with the requirements of the by-laws. A certificate of membership shall be issued to each member thereof, which certificate cannot be assigned so that the transferee can, by such transfer, become a member of the corporation except upon resolution of the board of directors and under such regulations as the by-laws may prescribe. The by-laws of the corporation shall provide the qualification of members and the terms and conditions of admission.

#### ARTICLE VIII

No member shall, individually, have or acquire any right, title, or interest in any of the earnings or accumulations of the corporation or its property.

The right and interests of all members shall be equal and each shall have equal voice and right at all meetings of members and the right to equal privileges upon the payment of uniform dues or charges as fixed by the directors under the by-laws, for the use and benefit of the different facilities and services offered by the corporation.

#### ARTICLE IX

The board of directors shall have power to direct and promote the activities of the corporation in addition to such other lawful powers as may be provided by the by-laws of the corporation.

It being expressly understood and agreed that no part of the net earnings of the corporation, its funds or property shall belong to or inure to the benefit of any member.
