ARTICLES OF INCORPORATION - NONPROFIT CORPORATION

We, the undersigned, residents of the State of Idaho, being of legal age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE ONE

NAME

The name of the corporation is the Quartz Mountain School, Inc.

ARTICLE TWO

ADDRESS

ARTICLE THREE

TYPE OF CORPORATION

The corporation is a nonprofit corporation.

ARTICLE FOUR

DURATION

The period of duration of this nonprofit corporation shall be perpetual.

ARTICLE FIVE

CORPORATION PURPOSE

This nonprofit corporation is organized for the following purposes: To establish and operate a school for persons ages three through seventeen covering the levels of kindergarten, lower elementary and through high school. To establish, mantain, and operate land, facilities, and equipment for use in connection with such institutions for the purpose of enjoyment and learning whether theoretical or practical. To diseminate knowledge in all areas whether academic, physical or vocations. The corporation shall have the right to do and accomplish all things and engage in any other lawful transactions which a corporation organized under the non-profit corporation laws of Idaho might do, accomplish or engage in.

ARTICLE SIX

NO PECUNIARY GAIN

This corporation is not organized for pecuiary profit. It shall not have any power to issue certificates of stock or declare benefit of any member, director, or individual. The corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and dostirbutions in the futherance of the purposes set forth in Article Five above.
