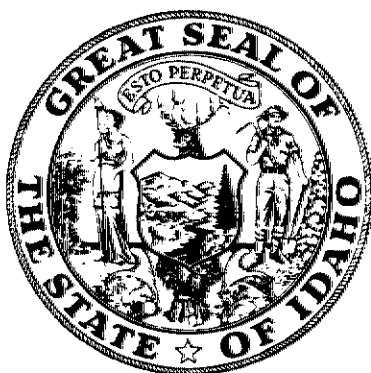


3. All notices required by Section 30-1-87, Idaho Code, have been given as required.

4. Adequate provision has been made for payment of all debts, obligations and liabilities of the corporation.


5. All the remaining property and assets of the corporation have been distributed among the stockholders in proportion to their respective rights and interests.
