RE: Rathdrum Food Bank – Use of the Word “Bank” in Company Name in Idaho

Dear Mr. Nass:

The Idaho Department of Finance (Department) received an email from you on March 14, 2024, requesting approval for use of the name “Rathdrum Food Bank” in the state of Idaho. Your email indicated that Rathdrum Food Bank is being set up as a 501(c)(3) organization to collect food donations from various sources and you are not conducting banking business in Idaho.

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word “bank” unless the person holds a banking charter. The Director of the Department, however, may grant a waiver to allow the use of the word “bank” in certain circumstances. The waiver may be granted if:

- (a) The person is not engaged in banking or trust business;
- (b) The name or title used is not likely to deceive or mislead an individual to believe that the person is engaged in banking or trust business;
- (c) The name or title, or a name or title similar to it, is not already used by another person doing business in this state; and
- (d) The name or title does not suggest or imply that the person is engaged in unlawful conduct.

Based on the information you provided, it appears that the four factors set forth above are applicable to your situation. Therefore, as delegated by the Director, I hereby grant a waiver to Rathdrum Food Bank to use and register that business and entity name in accordance with Idaho Code § 26-1202. Please be advised that if changes in circumstances or other facts occur or become known, this waiver may be retracted.


