ARTICLES OF INCORPORATION

OF

YANKEE FORK IRRIGATION COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That we the undersigned Ellis E. Higley, Helen E. Higley and Wayne L. Loveless, who are citizens of the State of Idaho and of the United States of America, and are bona fide residents of the State of Idaho all of whom are of legal age, have this day vountarily associated ourselves, and do by these articles of incorporation unite ourselves, for the purpose of forming a corporation under the laws of the State of Idaho and we hereby certify;

I

That the name of this corporation shall be the Yankee Fork Irrigation Company, Limited.

II

That the purposes for which said Corporation is formed are as follows:

To construct and maintain, reservoirs, dams, ditches, flumes, conducts, pumps, canals, and other instrumentalities of every kind, sort, name, and description wherein or whereby water may be carried or conveyed to and upon the lands of the stockholders of this company for domestic use, irrigation, or power purposes. Water is to be furnished to stockholders only. Said lands are situate lying and being in Custer County, Idaho.

To acquire, receive, hold, purchase, lease, mortgage, dispose of, and or convey real and personal property; and to preform such other acts and do such other things as are necessary and proper to accomplish these purposes and which are not repugnant to law.

III

The period of existence of this corporation shall be perpetual.

IV

The registered office at which the principal place of business of this corporation shall be conducted will be in the City of Salmon, County of Lemhi, State of Idaho.

V

The total authorized stock of this Corporation shall be twenty eight thousand (\$28000.00) dollars, and the number of shares into which it is divided is two thousand shares of a par value of 14 (\$14.00) dollars a share.

VI

The names, post office address and number of shares of stock subscribed by each incorporator are as follows:

VII

The number of directors of this corporation shall be three (3) and the qualifications, manner of election, and the powers and duties of the directors shall be prescribed by the by-laws.

VIII

These articles of incorporation may be amended in all respects, except where otherwise provided for by law, by the vote of the holders of a majority of the voting power of all the stock; and its by-laws may be amended or repealed and new by-laws adopted by the board of directors.
