



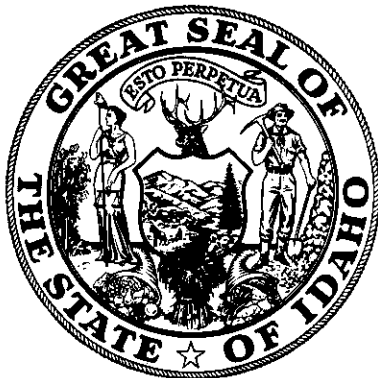
**CERTIFICATE OF INCORPORATION

ARTICLE ONE

The name of this corporation is TRAILER CRAFT INC.

ARTICLE TWO

The purpose for which this corporation is formed is all lawful business for which corporations may be incorporated in this State.

ARTICLE THREE

The address of the initial registered office of the corporation is 484 Washington, Montpelier, Idaho 83254, and the name of the initial registered agent at such address is Howard W. Matthews.

ARTICLE FOUR

The number of directors constituting the initial board of directors is three (3), and the name and address of the persons who are to serve as the directors until the first annual meeting of the shareholders, or until their successor is elected and qualified is:

The total number of shares of stock which the corporation shall have the authority to issue is Five Hundred Thousand (500,000) shares of common stock without par value, There shall only be one class of stock.
