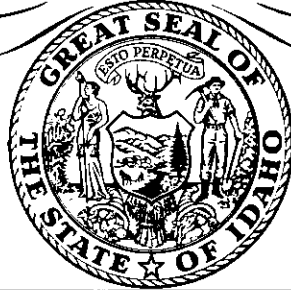

CERTIFICATE OF INCORPORATION

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho do hereby certify that the original of the articles of incorporation of

HAMPA SANITARY SERVICE, INC.

was filed in the office of the Secretary of State on the **Twenty-first** day of **February,** A.D. One Thousand Nine Hundred **Sixty-three** and duly recorded on Film No. **122** of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **perpetual existence** from the date hereof, with its registered office in this State located at **Hampa** in the County of **Canyon**

ARTICLES OF INCORPORATION
of
NAMPA SANITARY SERVICE, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States of America, this day having voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

Name

The name of this corporation shall be NAMPA SANITARY SERVICE, INC.

ARTICLE II

Purpose

That the purposes for which this corporation is formed are as follows:

(a). To enter into the operation of a rubbish and garbage collecting and general scavenger business, and to deal in scrap iron and salvaged metal and fiber products and articles, and to operate rubbish pits, garbage disposal units, and general dumping areas and service all business in connection therewith in the State of Idaho or in any state of the United States of America.

(b). To operate rubbish, trash, and garbage collecting routes and to provide related services, either interstate or intrastate, from time to time.

(c). To buy, sell, lease, or exchange real or personal property of every kind and nature and to mortgage the same from time to time.

(1).

(d). To borrow and to loan money upon either real or personal property; to become a mortgagor or mortgagee thereof, and to take and give assignments thereof.

(e). To buy, sell, trade, or otherwise negotiate, stocks, bonds, mortgages, and all other negotiable instruments of whatsoever kind and character.

(f). To do everything or things herein set forth to the same extent as fully as natural persons might do or could do in the State of Idaho, or in any state, country or place;

(g). To have offices, conduct its business and promote its objects within and without the State of Idaho, without restriction as to place or amount; and this corporation shall have the power to hold meetings within or without the State of Idaho as may be determined from time to time by its By-laws;

(h). In general, but in connection with the foregoing, said corporation shall have and exercise all of the powers conveyed by the State of Idaho upon business corporations, it being expressly provided that the foregoing enumeration of special powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE III

Duration

The period of existence and duration of the life of this corporation shall be perpetual.

ARTICLE IV

Place of Business

The location and post office address of the registered office of this corporation in the State of Idaho, shall be Nampa, Canyon County, Idaho.

ARTICLE V

Stock

This corporation is authorized to issue one class of shares of capital stock and shall be designated as common stock;

The total number of shares of common stock this corporation shall be authorized to issue is 1,000 shares;

The par value of each of the shares of common stock shall be \$100.00;

The total capitalization of this corporation shall be in the sum and amount of \$100,000.00.

ARTICLE VI

Incorporators

The names and post office addresses of each of the incorporators of this corporation and the number of shares of common stock subscribed by each are as follows:

Each of the persons above named as an incorporator is a natural person, over the age of twenty-one years and is a citizen of the United States of America.

ARTICLE VII

Directors

The number of directors of this corporation shall be at least three (3) and such additional number of directors as may be determined from time to time by the By-laws of the corporation.

ARTICLE VIII

Liability of Stockholders

The capital stock of this corporation shall be nonassessable and the private property of the shareholders in this corporation shall not be liable for the debts, obligations and liabilities of this corporation.

ARTICLE IX

Powers

The Board of Directors of this corporation shall have the power to repeal and amend the By-laws of this corporation and adopt new By-laws. Such power shall not extend to making or altering any By-laws, fixing the qualifications, classifications, term of office or compensation of the Board of Directors and this authority shall not be interpreted as taking from the shareholders that power and authority given to them by Section 30-133 Idaho Code, 1947, its amendments and additions.
