



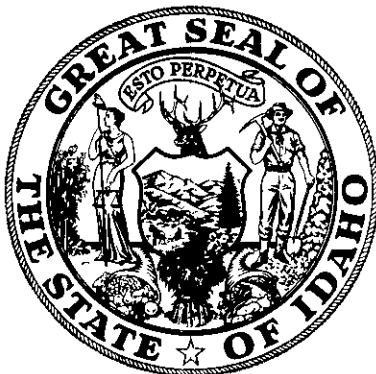
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION OF STATE

OF

ADVERTISING TECHNOLOGIES, INC.

KNOW ALL BY THESE PRESENTS:

That we, the undersigned, all being bona fide natural born citizens of the United States of America, over the age of twenty-one years, do, under and in pursuance of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves, and such other persons as may hereafter become associated with us, into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I.

That the name of this corporation shall be ADVERTISING TECHNOLOGIES, INC.

II.

That the period of existence of this corporation shall be perpetual.

III.

That the location and post office address of the registered office in the State of Idaho for the transaction of the business of this corporation shall be 106 East Third Street, Moscow, Idaho 83843, and the name of the registered agent at such address is A. J. Marineau.

IV.

In furtherance, and not in limitation of the general powers conferred by the laws of the State of Idaho, this corporation shall have the following objects, purposes and powers:

To construct, design, manage and sell display advertising material and space together with related goods and services.

3 hypothecate, pledge, sell or otherwise dispose of real or personal
4 property whatsoever that may be reasonably necessary for the pur-
5 pose of carrying into effect any one or more of the objects of

9 agreements, to borrow money, to lend money, to evidence the in-
10 debtedness of the corporation by notes, bonds, or other instru-
11 ments and to secure the same by pledge, mortgage, trust deed or
12 other instruments and to do all acts, and to make, execute and
13 deliver all necessary instruments for the carrying out of the
14 purposes of this corporation; to acquire and own the stock, bonds
15 and securities of other corporations and while owning the same to
16 exercise all the privileges of ownership consistent with the
17 corporate character of this corporation.

18 To act either as, or by and through principals, agents,
19 attorneys, trustees, contractors, factors, lessors, lessees or
20 otherwise, either alone or in connection with others; to do any
21 and all things convenient and incidental to the purposes herein
22 expressed, and generally to have and exercise all powers as are
23 by law conferred on corporations of like character, without in
24 any particular limiting any of the powers or purposes of the cor-
25 poration, and in connection with its objects to do any and all
26 things and to exercise any and all powers not prohibited by law.
