AMENDMENT TO ARTICLES OF

INCORPORATION OF

BE IT KNOWN, that we, the undersigned, President and Secretary, respectively, of BREEZ-WAY, INC. do hereby certify in accordance with the provisions of Section 30-146, Idaho Code, as follows:

- and outstanding stock of BREEZ-WAY, INC. was held at the offices of the corporation at 709 Steele Avenue, Rapid City, South Dakota, at ten o'clock A.M. on theninth day of December, 1968, pursuant to notice given more than thirty days prior to said meeting at which meeting all the issued and outstanding common stock was represented in person or by proxy.
- 2. That at said meeting, the following resolution was unanimously adopted, to wit:

"BE IT RESOLVED that Article FIFTH of the Articles of Incorporation of BREEZ-WAY, INC. be amended by deleting the entire article and inserting in place of it the following Article Fifth:

'FIFTH

The amount of the capital stock of this corporation shall be, and is Ten Million (10,000,000) Shares at no par value.'

And that the President and Secretary be, and they are hereby, authorized and directed to prepare a duly certified certificate of this amendment to the Articles of Incorporation, and to file the same with the Secretary of State of the State of Idaho, and at such other places as are necessary and/or convenient."

tion to be prepared, executed and filed as provided by the laws of Idaho.
