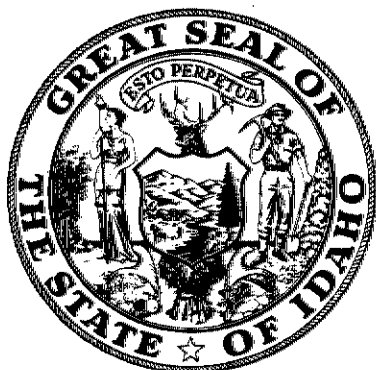

ARTICLES OF INCORPORATION  
OF THE  
WENDELL COMMUNITY ARTS COUNCIL, INC.

The undersigned, acting as incorporators of a non-profit corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such Corporation.

I

The name of the Corporation shall be the Wendell Community Arts Council, Inc.

II

The period of its duration shall be perpetual.

III

The purpose for which this Corporation is organized is to broaden the scope and interests of the community through exposure to and activities in a cultural arts program and to provide a backdrop for local talent.

No part of the net earnings of the Corporation shall inure to the benefits of, or be distributed to its members, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the foregoing paragraph hereof. No substantial part of the activities shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in any political campaign on behalf of any candidate for public office.

Additionally, the Corporation shall not carry on any other activities not permitted to be carried on either by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue Law) or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 (or the

corresponding provisions of any future United States Internal Revenue law).

Upon dissolution of the Corporation, the board of directors shall, after paying or making provision for payment of all liabilities of the Corporation, dispose of all the assets of the Corporation either for the furtherance of the purpose of the organization or to such organizations which are organized and operated exclusively for charitable, educational, literary, or scientific purposes and which shall, at that time, qualify as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue law). Any assets not so disposed of shall be disposed of by the District Court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as the Court shall determine.

#### IV

The address of the initial registered office of the Corporation is Rt. #1, Box 23, Wendell, ID 83355, and the name of its initial registered agent at such address is Ralph Daniels.

#### V

Membership in the Corporation will be open to any persons or entities interested in the purpose of the Corporation.

#### VI

The number of directors constituting the initial board of directors of the Corporation is five (5), and the names and addresses of the persons who are to serve as Directors are:




