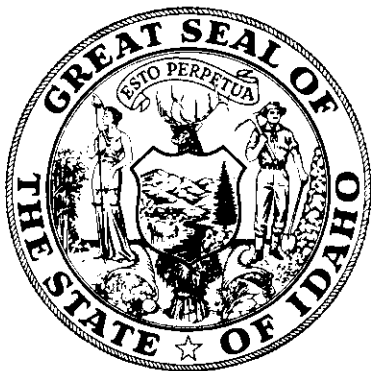

All remaining property and assets of the corporation have been distributed to its shareholder.






