1. **Name.** The name of the corporation is Mariposa Media, Ltd.
2. **Purpose of Corporation:** The purpose of the Mariposa Media, Ltd. is to provide internet and other media news and information about Clearwater County and other regional areas and any other legal or legitimate business enterprise or use.

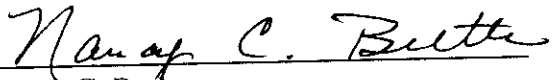
Sub-chapter "S" Corporation pursuant to 28 USC 1361 and 1362 and other applicable statutes, rules and regulations.
