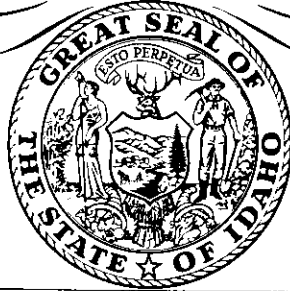

ARTICLES OF INCORPORATION
OF
STODDARD TRANSFER AND FUEL, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

I.

The name of the corporation is STODDARD TRANSFER AND FUEL, INC.

II.

Purposes for which said corporation is formed are:

1. To lease, buy, sell and sublease real estate and personal property connected with, or in any way appertaining to the operation of a transfer, moving, storage, fuel, or any other lawful business.

2. To carry on the business of transferring, moving, storage, fuel, or any other lawful business and to purchase, acquire, lease, loan and enjoy any and all such property as may be reasonably required for the carrying on of the business of the corporation.

3. To purchase or otherwise acquire, undertake, carry on, improve, or develop, all or any of the business, good will, rights, assets, and liabilities of any person, firm association, or corporation carrying on any kind of business of a similar nature to that which this corporation is authorized to carry on, pursuant to the provisions of this certificate; and to hold, utilize and in any manner dispose of the rights and property so acquired.

III.

This corporation shall have a perpetual existence.

IV.

The location of this corporation is Coeur d' Alene, Idaho, and its registered office is located at 218 Lakeside Avenue, Coeur d' Alene, Idaho.

V.

The total authorized number of shares is 500 shares of common stock having a par value of \$100.00 per share.

VI.

The capital with which this corporation will commence business is \$50,000.00.

VII.

The capital stock of this corporation shall consist of one class of stock; namely, the common stock having a value of \$100.00 per share, which stock shall be non-assessable.

VIII.

Each share of stock shall be entitled to one vote.


