1 AMENDMENT TO ARTICLES OF INCORPORATION

3 WESTERN AIRCRAFT, INC.

5 WHEREAS, at a meeting of the stockholders of the above
6 named corporation, duly and regularly called and held on the 9th
7 day of May, 1967, at the hour of 8:00 o'clock P. M. at the principal
8 office of the corporation in the City of Gooding, Idaho, at which
9 there were present and voting in person, or by proxy, stockholders
10 owning two-thirds of the capital stock of the said corporation,
11 there was presented and adopted by unanimous vote the following
12 resolution amending the Articles of Incorporation of said corpora-
13 tion, to-wit:

14 "RESOLVED, That Article V of the Articles of In-
15 corporation of Western Aircraft, Inc. be and the
same is hereby amended to read as follows:

16 ARTICLE V.
17 Stock

18 This corporation is authorized to issue one class
19 of shares of its capital stock to be designated as
20 common stock; the total number of shares of common
21 stock which this corporation shall be authorized
to issue is 2,500. The aggregate par value of the
stock of this corporation shall be \$250,000.00;
and the par value of each share of the common capi-
tal stock shall be \$100.00.

22 RESOLVED Further, that the President and Secretary
23 of the corporation be authorized to execute the
24 Amendment to the Articles of Incorporation and
swear thereto as required by the statutes of the
State of Idaho, and to do all acts and things neces-
sary in connection therewith."

27 ern Aircraft, Inc., a corporation, being duly authorized by the
28 resolution aforesaid, do hereby execute this Amendment of the
29 Articles of Incorporation amending Article V of the original


