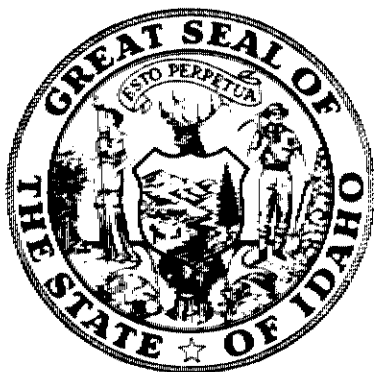

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
INTERMOUNTAIN EMERGENCY PHYSICIANS P. A.
An Idaho Corporation

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its articles of incorporation:

1. The name of the corporation is Intermountain Emergency Physicians P. A.
2. The following amendments to the articles of incorporation were adopted by the shareholders of the corporation on September 27, 1990, in a manner prescribed by the Idaho Business Corporation Act:
 - A. The articles of incorporation filed with the Idaho Secretary of State on October 22, 1987, are amended by deleting article I and substituting the following:

ARTICLE I


The name of the corporation shall be Snake River Emergency Services, P.A.


