Pursuant to the provisions of \$30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its articles of incorporation:

- The name of the corporation is Intermountain Emergency 1. Physicians P. A.
- The following amendments to the articles of incorporation 2. were adopted by the shareholders of the corporation on September 27, 1990, in a manner prescribed by the Idaho Business Corporation Act:
 - The articles of incorporation filed with the Idaho A. Secretary of State on October 22, 1987, are amended by deleting article I and substituting the following:
