ARTICLES OF INCORPORATION
OF
IDAHO FALLS COUNCIL OF THE NAVY LEAGUE

We, the undersigned, being persons of full age and citizens of the United States, hereby incorporate under the Idaho Non-Profit Corporation Act Sections 30-301, et. seq., Idaho Code.

ARTICLE I

The name of the corporation shall be Idaho Falls Council of the Navy League of the United States, Inc.

ARTICLE II

The corporation is formed as a non-profit corporation.

ARTICLE III

The duration of the corporation shall be perpetual.

ARTICLE IV

A. The objective and purpose of the Idaho Falls Council of the Navy League of the United States, Inc., shall be educational, and to that end, to acquire and spread information for the citizens of the United States as to the conditions of the naval and maritime forces and equipment of the United States, and to awaken interest and cooperation in all matters intending to aid, improve or develop their efficiency.

B. To acquire and hold, develop, improve, subdivide, lease construct, exchange, mortgage, sell, convey, finance or otherwise dispose of or deal in real estate.

C. To borrow or raise money for any of the purposes of the corporation and in connection therewith, to grant collateral or

other security, either alone or jointly with any other person, firm or corporation, and to make and issue promissory notes, drafts, bonds, debentures, and other evidences of indebtedness; and in general, do any all things to exercise in all powers which now or hereafter might be lawful for a non-profit corporation to do or exercise, under and in pursuance of the Idaho Non-Profit Corporation Act, or any other law which now or hereafter might be applicable to this corporation.

ARTICLE V

The corporation is to have six classes of members, designated as regular member, life member, honorary member, associate member, corporate member and business associate member; and the corporation by-laws shall specify the qualifications and rights of said members and the manner of election or appointment. The address of said directors is 163 North Lloyd Circle, Idaho Falls, Idaho.

ARTICLE VI

A board of directors of not less than three persons shall be elected by the members and shall manage the corporation. The initial directors shall be: C. Edwin Fend, Milton F. Adam, and Archie B. Browning, who shall hold office until the first annual election of the directors or until such time as a successor has been named.

ARTICLE VII

The corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be

amended. Further, upon the dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its regulations.


ARTICLE VIII

The officers of said corporation, elected by the directors, shall be C. Edwin Fend, President; Archie B. Browning, Vice-President; and Milton F. Adam, Secretary/Treasurer.

ARTICLE IX

The principal organizer, incorporator, and the initial registered agent of the corporation is C. Edwin Fend and the address of the initial registered office of the corporation is 163 North Lloyd Circle, Idaho Falls, Idaho 83402.
