## ARTICLES OF AMENDMENT

OF

## NORTH IDAHO DISTRICT MEDICAL SERVICE BUREAU, INC.

#### an Idaho corporation

KNOW ALL MEN BY THESE PRESENTS: That David W. Heusinkveld, President, and Walter W. Seibly, Secretary, of the above-named corporation, respectfully represent that the above-named corporation was incorporated under the laws of the State of Idaho and is a duly qualified corporation, operating under and pursuant to Chapter 34, Title 41, Idaho Code; that on the 12th day of January, 1977, at a meeting of said corporation held pursuant to due notice of said meeting for the specified purpose, among others as set forth in said notice, of amending the Articles of Incorporation, and at which meeting a majority of the members of said corporation were present in person or by proxy, the following resolution was duly moved and seconded:

"BE IT HEREBY RESOLVED, that ARTICLE I of the Articles of Incoroporation of North Idaho District Medical Service Bureau, Inc., be amended to read as follows, to-wit:

"ARTICLE I. The name of this corporation shall be 'Medical Service Bureau of Idaho, Inc.'

"BE IT FURTHER RESOLVED, that all other provisions of the Articles of Incorporation, as heretofore amended, and as hereby constituted, be ratified and affirmed."

That upon being put to a vote, the aforementioned resolution was passed unanimously, all present and entitled to vote, voting in the affirmative, and the President and Secretary were advised and authorized to issue their certificate to the Secretary of State of the State of Idaho for the purpose of amending the Articles of Incorporation in compliance with this resolution.
