The name of the corporation is the Preferred General Agency incorporated. The effective date of its incorporation was September 15, 1976.

The following amendment of the Articles of incorporation was adopted by the scareholders of the corporation on February 16, 1977, in the manner prescribed by the lows fusiness Corporations Act.

Article 1 of the Articles of Incorporation is amended to read: The name of the corporation is the Career General Agency, Incorporated.

ARTICLE III

The number of shares outstanding at the time of the adoption was 5,000 all of which were entitled to vote.

ARTICLE IV

All of the outstanding shares were owned by the Preferred Risk Mutual Insurance Company and all shares were voted in favor of the amendment.
