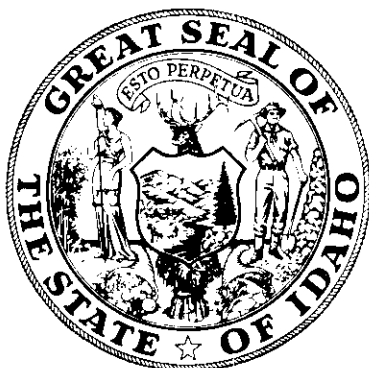

ARTICLES OF INCORPORATION
OF
AKERS AND WRIGHT INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is AKERS AND WRIGHT INC.

SECOND: The period of its duration is perpetual.

THIRD: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to do any or all the things herein mentioned, as fully and to the same extent as natural persons might, or could do, in any part of the world, to-wit:

(a) To conduct any and all types of logging functions including but not limited to: logging, log hauling, road building, manufacture of any and all lumber products of every type.

(b) To do farming, equipment hauling, equipment maintenance work, and any other function related to the ownership of equipment of any type.

(c) To manufacture, purchase or acquire in any lawful manner and to hold, own, mortgage, pledge, sell, transfer,

(f) To do any or all of the things herein set forth to the same extent as natural persons might or could do in any part of the world, as principals, agents, contractors, trustees, or otherwise, and either alone or in company with others.

(g) To conduct or transact any or all lawful business of any type for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ONE MILLION (1,000,000) SHARES of non-assessable stock having a par value of ONE DOLLAR (\$1.00) per share for a total authorized capitalization of \$1,000,000.00.

FIFTH: Any outstanding shares of stock for sale must be first offered in writing to the corporation or to an existing stockholder, and any sale of stock not conforming herewith is void.

SIXTH: The address of initial registered office of the corporation is 3712 Moccasin, Coeur d'Alene, Idaho, and the name of its initial registered agent at such address is GALE W. AKERS.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is two, and

the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and qualified are:
