# ARTICLES OF INCORPORATION.

KNOW ALL MAN BY THESE PRESENTS, that we, the undersigned, bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the Laws of the State of Idaho.

#### Article 1.

The name of this corporation shall be the "Weiser Flat Pipe Line Company, Limited"

### Article 2.

The purposes for which this corporation is formed are to appropriate, locate, file upon, purchase, acquire, lease and own water and water rights for irrigation, household, domestick and other purposes; to lease, sell, furnish or deliver to stockholders or consumers, as may be provided by the by-laws of said corporation, water and water rights for said purposes; to construct, enlarge, operate and maintain a water rumping system with all proper equipment therefor, together with, or separately, a system of canals, pipe line or lines, with proper head gates, distributing valaves or gates, and all other equipment that may be necessary or desirable for the convenient or useful operation of the same for any or all of said purposes, and in general to do any and all things proper or necessary for the complete, convenient and economic building, operating and maintaining a system of water distribution by any means whatsoever, including the parchasing, owning or acquiring of lands, rights-of-way or equipment for the laying, constructing and operating said pipe line or lines, eanals, water and water pumping system and sell the same when not needed; to borrow money on the credit of the Company for the purposes above set forth and to issue and soll and dispose of bonds therfor or give other security, and to do may and all things necessary to carry on the business and objects of this organization.

The place where the principal business of this corporation is to be transacted is in the City of Weiser, Washington County, Idaho.

## Article 4.

This corporation shall exist for the period of fifty years from and after the 4th day of August, 1910.

The number of Directors of this corporation shall be three, to be elected annually.
