

ARTICLES OF INCORPORATION

OF

SMITH AND ASSOCIATES RETIREMENT PLANNING CONSULTANTS, INC.

I, the undersigned natural person of the age of twenty-one
(21) years or more, acting as incorporator under the Oregon
Business Corporation Act, adopt the following Articles of
Incorporation:

ARTICLE I.

The name of the corporation is SMITH AND ASSOCIATES

RETIREMENT PLANNING CONSULTANTS, INC., and its duration shall be perpetual.

ARTICLE II.

The initial registered office of the corporation in the State of Oregon is 1013 N.W. Brooks Street, Bend, Oregon, 97701, and the initial registered agent for the corporation is William R. Mattecheck.

ARTICLE III.

The purpose and powers of the corporation are:

- To engage in sales of insurance and consultation for retirement plans;
- 2. To engage in any and all lawful activities for which corporations may be organized under ORS Chapter 57; and

- 2. No shareholder shall have the preferential or pre-emptive right to subscribe for or purchase any stock of any class, any rights, warrants or options with respect thereto, or any obligation convertible to or exchangeable for any stock or other security, whether out of unissued stock or other securities or out of stock or other securities acquired by the corporation after the issue of the stock, regardless of the consideration.
- 3. Each shareholder shall have one vote for each share held of record on all matters submitted for shareholder approval. No shareholder shall be entitled to accumulate his votes for election of directors.
