KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned being natural persons of full age and citizens fo the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the General Business Corporation Act of Idaho, as set forth in Title 30, Idaho Code, Volume 5B, do hereby certify as follows:

The name of the corporation is BAKER U.S.A. FERTILIZER CO., INC.

I]

The purposes for which said corporation is formed are:

- (a) To manufacture and sell commercial grade fertilizer of types and kinds.
- (b) To do all things necessary or incidental to accomplish the foregoing objects and purposes of such business or businesses; and
- (c) To transact any or all lawful business for which corporations may be incorporated under the Genreal Business Corporation Act as now contained in Title 30, Idaho Code, Volume 5B, or as may be hereinafter amended.
