**ARTICLES OF INCORPORATION  
OF  
BOISE FAITH FELLOWSHIP, INC.**

KNOW ALL MEN BY THESE PRESENTS: That, I , t h e undersigned, being a natural person of full age and a citizen of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Nonprofit Corporation Laws of the State of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

**ARTICLE I**

That the name of the corporation is Boise Faith Fellowship, Inc.

**ARTICLE II**

The corporation shall be a nonprofit corporation.

**ARTICLE III**

The corporation is to have a perpetual existence.

**ARTICLE IV**

The corporation is organized as a church and for any lawful purpose or purposes permitted by law.

**ARTICLE V**

The number of directors of the corporation shall be as specified in the By-Laws, and such number may from time to time be increased or decreased in such manner as may be prescribed in the By-Laws.

**ARTICLE VI**

The address of the initial registered office of the corporation shall be 443 Mesquite Street, Boise, ID 83704, and the name of the registered agent at such address shall be Gary N. Holcombe.

ARTICLE VII



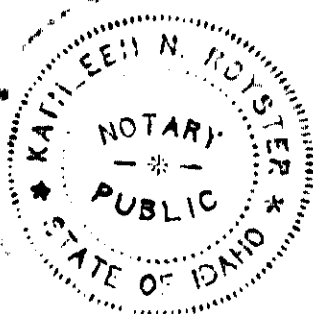


