KNOW ALL MEN BY THESE PRESENTS: That, I, the undersigned, being a natural person of full age and a citizen of the United States, in order to form a nonprofit corporation for the purposes hereinafter stated, under and pursuant to the provisions of the Nonprofit Corporation Laws of the State of Idaho, and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

#### ARTICLE I

That the name of the corporation is Boise Faith Fellowship, Inc.

## ARTICLE II

The corporation shall be a nonprofit corporation.

#### ARTICLE III

The corporation is to have a perpetual existence.

#### ARTICLE IV
