2. The purposes for which it is formed is to carry on a ~~general merchandise business~~ general retail and wholesale hardware business, and to purchase and hold such real estate as may be necessary in the conduct of its business, and to do any and all acts and things necessary for the carrying on of such business.

3. The place where its principal place of business is to be transacted is Coeur d'Alene, County of Kootenai, State of Idaho.

4. The term for which it is to exist shall be fifty(50) years.
