The undersigned, being a duly licensed physician qualified to practice medicine pursuant to the laws of the State of Idaho, for the purpose of forming a professional corporation under the "Professional Service Corporation Act" of the State of Idaho, adopt the following Articles of Incorporation for such corporation."

FIRST: The name of the corporation is Carl M. Melina, M.D., P.C.

<u>SECOND</u>: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the rendering of professional services of a physician and engaging in the practice of medicine in the State of Idaho and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Professional Service Corporation Act.
