

ARTICLES OF INCORPORATION

TAB TRUCKING, INC.

KNOW ALL MEN BY THESE PRESENTS: That MERLIN BLACK, being over the age of twenty-one (21) years, and for the purpose of forming a corporation under the Washington Business Corporation Act does hereby certify and adopt in triplicate the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be TAB TRUCKING, INC., and its existence shall be perpetual.

ARTICLE II

The purpose and objects of this corporation are as follows:

- 1. To operate a general trucking business and to operate trucks as contract carriers and common carriers.
- 2. To carry freight for hire; to receive and load all varieties of commercial freight on board highway motor vehicles; to transport such freight to various destinations throughout the United States; and to buy, sell, and otherwise deal in and with tractors and trailers suitable for commercial trucking, and to maintain and repair the same.
- 3. To engage in generally and carry on any lawful business or trade which may, in the judgment of the Board of Directors, at any time be necessary, useful or advantageous to this corporation.

- 4. In furtherance of and not in limitation of the general powers conferred by the laws of the State of Washington, it is expressly provided that this corporation shall also have the following powers:
 - (a) To acquire by purchase or otherwise and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the stock of this corporation, provided that the money or property of the corporation shall not be used for purchase of shares of its own stock when such use would cause any impairment of the capital of the corporation. The corporation shall not be entitled to vote, either directly or indirectly, on any shares of its own stock which it may hold.
 - (b) To acquire by purchase or otherwise and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the bonds, debentures, notes and other securities and obligations of this corporation.
 - (c) To borrow money and give security therefor.
 - (d) To enter into, make, perform and carry out contracts of every kind for any lawful purposes pertaining to its business, with any individual, entity, firm, association, or corporation, or with any governmental, municipal, or public authority, domestic or foreign.
 - (e) To do everything necessary, proper, convenient, or incidental to the accomplishment of the purposes and objects of this corporation, or which is calculated directly or indirectly to promote the welfare or interests of the corporation or enhance the value or render profitable any of its property or rights.
 - (f) To do any and all of the things in this article set forth to the same extent a natural person might or could do, and in any part of the world, as principals, agents, contractors, trustees, or otherwise, either alone or in company with others.

PROVIDED. HOWEVER, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business, to exercise any power or to do any act which a corporation formed under the

Uniform Business Corporation Act of the State of Washington, or any amendment thereto or substitute therefor, may not at the time lawfully carry on or do.

ARTICLE III

Shareholders of this corporation shall have no pre-emptive rights to acquire additional shares offered for sale by the corporation.

ARTICLE IV

- 1. The location and post office address of the registered office of the corporation in this State shall be East 3628 Syndicate Boulevard, Spokane, Washington 99202.
- 2. The registered agent of the corporation shall be MERLIN BLACK, East 3628 Syndicate Boulevard, Spokane, Washington 99202.

ARTICLE V

The authorized capitalization of the corporation shall be Fifty Thousand Dollars (\$50,000.00), consisting of common stock having a par value of One Dollar (\$1.00) each.

The corporation reserves the right to amend, alter, change, or repeal any provisions contained in its Articles of Incorporation in any manner now or hereafter prescribed or permitted by statute. All rights of stockholders of the corporation are granted subject to this reservation.

ARTICLE VI

The amount of paid-in capital with which the corporation will begin business is Five Hundred Dollars (\$500.00).

ARTICLE VII

- 1. The number of directors of the corporation shall be fixed as provided in the By-Laws, and may be changed from time to time by amending the By-Laws, as therein provided, but the number of directors shall not be less than three nor more than nine.
- 2. In furtherance of and not in limitation of the powers conferred by the laws of the State of Washington, the Board of Directors is expressly authorized to make, alter, and repeal the By-Laws of the corporation, subject to the powers of the stockholders of the corporation to change or repeal such By-Laws.
- 3. Any contract, transaction, or act of the corporation or of the directors or of any officers of the corporation which shall be ratified by a majority of a quorum of the stockholders of the corporation at any annual meeting or any special meeting called for such purpose, shall insofar as permitted by law, be as valid and as binding as though ratified by every stockholder of the corporation.
- 4. The first directors of this corporation shall be three (3) in number, and their post office addresses are as follows:

The term of the first directors shall be until the first annual meeting of the stockholders of the corporation, to be held on

the third Monday of October, 1975.
