KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho;

AND WE HEREBY CERTIFY:

First,- That the name of said Corporation is "The Silver Grocery Company,"(Limited).

Second,- That the purpose for which it is formed is to carry on a general merchandise business; to buy and sell groceries, provisions, dry goods, clothing, and all articles kept in a general merchandise business; to buy, sell, contract for, and do a general business in Lumber, Logs, Telegraph Poles, Railroad cross ties, fence posts, Cord Wood, and timber for railroad and building purposes; to own, lease, buy and sell real estate.

Third,- That the place where its principal place of business is to be transacted shall be at the town of Sand Point, Kootenai County, State of Idaho.

Fourth,- That the term for which it is to exist is twenty-five (25) years.

Fifth,- That the number of its directors shall be five, and the names and residences of those who are appointed for the first year, are as follows:
