ARTICLES OF INCORPORATION

OF

ADVANCED HEATING & COOLING, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is: Advanced Heating & Cooling, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The powers or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

Provided; that no redemption or purchase of redeemable shares of stock shall be made by the corporation when it is insolvent or when such redemption or purchase would render it insolvent, or which would reduce the net assets below the aggregate amount payable to the holders of shares having prior or equal rights to the assets of the corporation upon involuntary dissolution.

FOURTH: There shall be two classes of common stock and shares which the corporation shall have authority to issue shall be as follows:

Class A 10,000 Shares with no par value.
Class B 300 Shares with \$10.00 par value.

Class B shares shall have no voting rights in the affairs of the corporation except as provided by law and shall have prior right to the payment of dividends. Class A shares shall hold all voting rights in the affairs of the corporation and rights to dividends shall be subject to the rights to dividends to Class B shares, all as determined by the Board of Directors.

FIFTH: The address of the initial registered office of the corporation is 113 South 24th Street, Boise, Idaho, and the name of its initial registered agent and address is Gary C. Asin, 113 South 24th Street, Boise, Idaho.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until successors are elected
