ARTICLES OF INCORPORATION

OF

COUGAR GULCH/BLACKWELL HILLS HOMEOWNERS ASSOCIATION, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporations Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is COUGAR GULCH/BLACKWELL HILLS HOMEOWNERS ASSOCIATION, INC.

SECOND: The corporation is formed as a private non-profit corporation.

THIRD: The period of its duration is perpetual.

FOURTH: The purpose or purposes for which the corporation is organized are:

- A. To conduct and carry on the work of the corporation, not for profit, but exclusively for social, civic and fraternal purposes.
- B. The transaction of any or all lawful business for which non-profit corporations may be incorporated under the Idaho Business Corporations Act, and the Idaho Nonprofit Corporation Act.

FIFTH: This shall be a non-stock corporation. The By-Laws of this corporation shall provide for the number and qualifications of members and the terms and conditions of admission to membership. The rights and interests of all members shall be equal and no member shall have or acquire a greater interest than any other member. No member can have or acquire any right, title or interest in any of the earnings or accumulations of the corporation or its property.

SIXTH: The address of the initial registered office of the corporation is Meadowbrook Road, Route 1, Box 25, Coeur d'Alene, Idaho 83814, and the name of its initial registered agent at such address is THOMAS B. LUCAS.

SEVENTH: The number of directors constituting the initial board of directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
