ARTICLES OF INCORPORATION  
OF

The undersigned, MARK DUNKEL and ARLANA DUNKEL, being qualified as incorporators of a corporation under the Idaho Business Corporate Act, of legal age, enter into these Articles for the purpose of forming a corporation under the laws of the State of Idaho, and do hereby make, adopt, execute, and acknowledge these Articles of Incorporation as follows:

ARTICLE I: Corporate Name

The name of the corporation shall be MARK, INC.

ARTICLE II: Shares

The corporation shall have authority to issue 500,000 shares of common voting stock.

ARTICLE III: Initial Registered Office and Registered Agent

The initial registered office of the corporation shall be located at 313 Birch Street, Ponderay, Idaho. The initial registered agent at the address shall be MARK DUNKEL.

ARTICLE IV: Initial Board of Directors

The number of directors of this corporation shall be not less than one nor more than nine. The initial Board of Directors of

this corporation shall consist of two board members, who shall be MARK DUNKEL and ARLANA DUNKEL, whose addresses are P.O. Box 288, Ponderay, Idaho 83852. MARK DUNKEL shall be the initial chairperson of the Board of Directors. The initial directors shall serve as the Board of Directors until the first annual meeting of shareholders or until the successors have been elected and qualified.

ARTICLE V: Incorporator

ARTICLE VI: Corporate Purpose

All shareholders are entitled to preemptive rights.

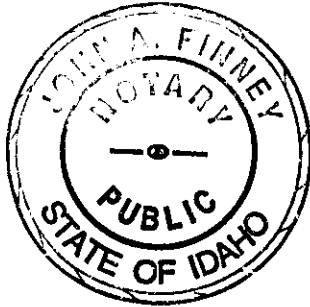
